Barn Rules

Member hours are 8 am to 7 pm each day. The arena(s) are open for member use – unless there is a clinic scheduled. Notification of arena closing will be posted.

Safety First – in case of human emergency call 911

NO SMOKING ON PREMISES

NO DOGS on grounds (unless on a leash to potty and back into vehicle)

Guests are not permitted to handle, ride, or participate with a member horse in any capacity unless cleared with management, and a liability waiver must be signed PRIOR to commencement (including entering paddocks or pastures). Guests **MUST BE** accompanied by a member each visit. We are not open to public riding for the safety, health, convenience, and peace of mind of our members and training clients.

Outside Instructors/Trainers: Our facility is used primarily for our clients in regards to training, lessons, boarding, and sale previews; which means additional parties using the arena affects the facilities schedule, other members, facility overhead, and business. For this reason we only permit outside instructors/trainers on a very limited basis. Prior approval of any instructor or trainer is required; and they (instructor/trainer) need to contact management directly to discuss scheduling, fees, and requirements. The arena is available for daily or weekend rent as well. Contact management for rates/availability.

All persons under 18 are required to wear a riding helmet.

Helmets are encouraged for all riders/disciplines. Riders who are going over fences (jumps) must wear a helmet.

Order and Cleanliness of the barn, tack room, and surrounding areas is of high importance. It is every member's duty to **promptly** clean up your horses manure, grooming debris, urine, etc, from the barn alley, tack up stalls, outside tie area, wash bay, parking area, and arena. Buckets, scoops, brooms can all be located at the entrance of the barn and in several other designated areas.

If you don't know..... Ask (cell phone numbers for management listed below)

No feeding or treats are to be given to non-owned horses

ABSOLUTELY no tying to stall bars. No tacking in alley; Tack up is available in a wash rack, inside the arena, or stall(s) #1 thru #5.

Shavings, hay, etc. is not for members to handle/take without consent. Hay barn is off limits. Shavings are available for purchase at \$7/bag.

Horses are housed depending on temperament, sex, health needs, etc., if you have a special request please discuss with management. For the safety and well-being of horses and humans; Horses who are difficult or destructive may be required to move or be unable to stay if a solution can't be reached.

Lessons are to start at specified time. Lessons are semi-private. Member riding in the arena during a lesson is permitted unless otherwise posted.

ALWAYS close gates, shut off lights, close doors, and pick up after yourself and your horse.

Children under 16 must be accompanied by an adult. No children are permitted to roam barn area, pastures, etc. alone.

Park in designated areas only, the driveway speed limit is **10 mph**. The private drive speed limit is **25 mph (Meredith Ranch Road, and attached roads)**.

Campbell Horses LLC and Eagle Vista LLC are not responsible for lost, stolen, or damaged items left at the barn.

Campbell Horses LLC and Eagle Vista LLC are not liable for injury or death of a person or equine. If you desire an insurance policy on your horse, please let us know. We can refer you to several wonderful carriers.

We reserve the right to charge for any damages your or your horse might cause to our facilities (stall, barn, fencing, arena, etc). Normal wear and tear is excluded.
